PUBLIC COMMENTS

Members of the public may speak on an agenda item during the public forum section of the meeting or when the agenda item is called for discussion by the Mayor. Speakers are limited to **three (3) minutes per speaker**. Time may not be saved, transferred, or assigned.

Members of the public wishing to address the Council on **non-agenda items** may do so during the public forum, subject to the same three (3) minute limit. Consistent with the Texas Open Meetings Act, Council Members may not discuss or respond to non-agenda items.

All speakers are expected to maintain proper decorum. Threats, personal insults, vulgar, or profane language are out of order and may result in forfeiture of remaining time and removal from the meeting.

Citizens wishing to comment must submit a written request to the City Secretary **no later than 10 minutes prior to the meeting**.

This meeting notice also constitutes notice of potential meetings of other City boards, commissions, or committees whose members may attend and discuss the above-listed items. No action by such boards, commissions, or committees will be taken unless expressly stated on their agendas.
